Request to renew existing Organized Crime Initiative Agreement with Public Safety Canada. The Initiative has been undertaken to increase the operational, investigative, and intelligence capacity of the Peacekeepers, with officers dedicated to gathering intel on organized crime and criminal activity on the Territory. The Agreement is for five (5) years at \$760,000 per year. Frankie McComber is authorized to sign the Agreement on behalf of the MCK. **Passed by Consensus**
