Discussion: Community Events

Discussion: Community meetings

Discussion: Proposed Residential Project Update

Discussion surrounding MCK's support for the Land Back encampment who are occupying the territory along the Old Chateauguay Road to stand against development of a residential area on Kahnawà:ke lands. Nitsénhaienhs Mike Delisle, Jr. and Ross Montour, along with Winona Polson-Lahache and Roseann Morris are directed to approach the Land Back group with an offer to share and present information on the Seigneury Land Grievance. Winona Polson-Lahache is mandated to assist in liaising information and messages where necessary. It was directed that there be a re-distribution of information surrounding the Seigneury of Sault St-Louis to the community.
