Discussion: Landfill, 2015 Season

Presence of Kevin Kennedy, Ken Bourque, Arnold Lazare (Interim Kahnawà:ke Landfill Authority), Theresa Delisle (Interim Landfill Coordinator), Kevin Fleischer (Legal Services). Presentation of the 2014 Report on Landfill, and the Recommendations for the 2015 Landfill Season. Presented on a preliminary basis for information and discussion purposes. Discussions/Updates

• Discussion on Membership issue. Mike Delisle spoke to a group of concerned citizens regarding the planned delivery of letters to people ineligible to reside on the Territory due to the contravention of the *Kahnawà:ke Membership Law*. The aforementioned letters are not being delivered by, or on behalf of, the MCK. The Peacekeepers have not consented to deliver the letters, as well. Grand Chief instructed the group to speak to the Peacekeepers directly. Chief & Council to meet further on this issue.
