# Update on Increase in Number of Poker Tables/Discussion on Lottery Regulations

Presence of Murray Marshall, Dean Montour, Marnie Lahache (Kahnawake Gaming Commission), Dwaine White. Discussion on possible increase to 25 tables (from 15) for poker halls. As well, some discussion on increasing mandatory tribute to MCK, which currently stands at \$2,500 per year per operator. Discussion on lottery regulations deferred.
