Request for Decision, Mohawk Council Resolution: Enactment of *Kahnawà:ke Justice System Law*

Presence of Ron Skye, Kevin Fleischer, Leslie Skye, Kim Beauvais, Joe Delaronde. Confirmation of Community Will, which was received on November 12, 2014. Law will be implemented on an incremental basis pending financial and human resources. Passed unanimously (see press release dated 15, Ohiari:ha/June for details).

Request for Decision, Mohawk Council Executive Directive: Approval of Amendments to Interim Landfill Policy & Procedures for Clean Soil

Presence of Arniold Lazare, Ken Bourque, Kevin Kennedy (Interim Landfill Authority), Kevin Fleischer (MCK Legal Services). In the aftermath of the suspension of the standard Landfill policies and procedures in December 2013, the Interim Landfill Policy for Clean Soil and Interim Landfill Procedures for Clean Soil were passed by Chief & Council in June 2014 and implemented as a temporary measure to authorize limited landfill operations. Amendments were approved today for improved accountability, and better clarity and applicability within the two documents. It was made clear that the improvements will continue and that further amendments to both the policies and procedures are forthcoming. Passed unanimously.

 Presse article on Mt. Kaikkop. He ensured Chief Whiteduck is aware that the
 situation at Mt. Kaikkop was not an Aboriginal rights case, as may have been
 implied in the article
