Request for Decision: Telecommunications - Antenna System Siting Position

Presence of Tom Scott (Technician, Telecommunications Working Group). In an effort to limit the number of antennas and prevent the installation of antennas on private land, the Antenna Siting System Protocol will ensure that telecommunications companies use existing buildings, structures and antennas before installing a new antenna. It will also ensure the towers are built according to industry standards and meet all local safety standards. Passed unanimously.
