### Updates/Discussions:

- Lloyd Phillips update on Comprehensive Claims Process discussions at recent Assembly of First Nations of Quebec & Labrador meetings
- Discussion on Highway 30 truck stop project. Tewatohnhi'saktha's John Bud Morris will be asked to update the table in the near future
- Gina Deer and Mike Delisle were given approval to re-open discussions with local gas
  retailers
- Clinton Phillips asked for update re: Martin Leborgne and Bobby Patton meeting with Enbridge in Kingston. After some discussion, Chief Leborgne told table he is removing himself from the Enbridge file. Strategic discussion on this topic will be scheduled
- Mike Delisle: informed the table that a brief meeting last week with Trans-Canada Pipeline regarding their upcoming major project was 'useless'
- Martin Leborgne asked if the recent Kahnawà:ke/Quebec labor agreement was available to the public. Lloyd Phillips informed the table that it should be available by the end of this week. Chief Phillips indicated that the new agreement should have little impact on the Mercier Bridge works, focusing on the Kateri Memorial Hospital Center expansion project. He indicated that Quebec has agreed to amend several of their laws in accommodation of the labor agreement
- Gina Deer: informed table that she will be meeting with area mayors regarding various issues, including concerns over Route 207. Chief Deer will speak with Rhonda Kirby to ensure she has up-to-date information
