# Request for Decision, Mohawk Council Executive Directive: Medical Facility project

Presence of Dale Montour (consultant), and Paul Rice. Mandate given to create a preliminary working group to explore potential medical facility project. The Working Group will consist of Grand Chief Joe Norton, Economic Development Portfolio Chief Gina Deer (with Martin Leborgne as her alternate), Winona Polson-Lahache, Paul Rice and Jean Pommainville (MCK Legal Services). A larger, more comprehensive working group would be created should the project move past this initial stage. Agreement that a non-disclosure agreement would be signed by both parties should the project proceed. Passed unanimously
