#### For immediate release

**(Kahnawake – 24 Seskéha/August 2009)** The Mohawk Council of Kahnawà:ke wishes to inform the community that Chief & Council have discussed and confirmed portfolio assignments for the 2009-2012 Council term (see attached documents).

“There are a great many challenges that continue to face not only the MCK, but all of Kahnawà:ke,” said Grand Chief Michael Ahrírhon Delisle, Jr. “Now that the portfolios have been assigned, we can begin the work to meet these challenges.”

At this time, there is still one vacant seat at the Council table. A by-election will be held on Wednesday, 9 Seskehkó:wa/September to fill the vacancy. Afterward, there will be some adjustments to the portfolio assignments, as Chief & Council have acknowledged the need for inclusion of the newest member of the table.
