Notice to Kanawaki Lot Holders regarding Lease

(Kahnawake – 10, Seskehkó:wa/September 2021) The Mohawk Council of Kahnawà:ke (MCK) wishes to advise lot holders of Kanawaki Golf Club lands regarding <u>important developments on the</u> <u>Lease Agreement negotiations</u>. Since Indigenous Services Canada (ISC) is responsible for the administration of the lease, it is in the process of mailing letters to the affected lot holders explaining these developments.

As per the lease, Kanawaki has opted to renew for an additional 25year term, for the period extending from December 1, 2021 to November 30, 2046. As the community is aware, this will be the <u>final</u> <u>extension</u> of the lease. ISC and the mandated representatives of the MCK have negotiated an agreement in principle on the lease renewal and in regard to the lease amount. The next step in this process is a consultation with the lot holders before formally accepting or rejecting the proposed rent.

In order to meet the requirements of the agreement, ISC has scheduled a videoconference via Microsoft Teams with all available affected lot holders to ensure the communication of all necessary information. There will be an opportunity for lot holders to ask questions during the meeting and direct any concerns that they may have. This meeting will take place on Tuesday, September 28, 2021 at 7 pm.

The date of October 8, 2021 has been set as the deadline to voice any concerns to the proposed agreement in principle. Following this consultation period, if the negotiated amount is not acceptable, the rental amount will have to be decided via arbitration. That being said, once arbitration is triggered there is no guarantee that ISC will be able to obtain a rental amount equal to or greater than the negotiated lease amount. The final decision would be in the hands of the independent arbitrators.
