LAND USE SURVEY RESULTS 2016 - SYNOPSIS

The following is a synopsis from the MCK Public Relations Unit, regarding the Land Use survey results.

Overall, the survey results show very mixed feelings regarding land issues. Based on the results, no one issue is deemed unimportant and it seems as though all land issues are important.

When asked to prioritize, the only issue that stood out was future housing development. 200 survey participants had 11 choices to select 5 items to prioritize. Every single item was chosen by over 100 people, again citing that all issues are important.

Other aspects of the survey show that this is common - that all land issues are important.

There is no doubt Community members want to and need to be involved. The Land Use Planning Project has a Kahnawà:ke Land Use Plan Framework Steering Committee in place to provide insight and guidance to the project coordinator, as needed. Also, focus groups are currently being held in Kahnawà:ke with the aim that the participants will represent a broad cross-section of the community.

However, the survey participants agreed that the biggest hurdle will be Community participation and agreement.

Of note, over 75% felt that the Community Vision of the future of land use should be a main focus. Of special note, over 75% of those who took the survey were women, which demonstrates that, as caretakers of the land, women had more interest in this survey.

Based on the survey results, MCK Public Relations recommended the following to MCK Lands:

- Create 10 themes
- Run a 30 week educational campaign
- Hold special meetings on key issues
- Use surveys, focus groups, meetings or workshops to get proper feedback per theme, rather than all at once and not using the same method for all 10
- Hold a Lands Conference after 30 weeks, with workshops to validate the results of the feedback
- Possibly hold one final Community survey to validate the results of the workshop and/or at least see which areas the Community does agree on.

SURVEY RESULTS SYNOPSIS FROM THE LANDS UNIT

Last year the MCK Lands Unit did surveys to gather community feedback on Land Use Planning. The surveys were done from February to early April of 2016. In total, 202 surveys were completed. They were done in-person and over the phone. We didn't record the identities of the participants.

The first question was, "in which of the following areas should there be a Land Use Plan?" The top 2 responses were residential development and preservation of our lands.

The survey also asked "Who should be involved in the development of a Land Use Plan?" and the #1 response was community members. so This aligns with the main goal of the project which was to have the framework development be based entirely on community feedback.

We asked what people's biggest land related concerns were, and the top ranked answer was a "Lack of Land", next was "the contaminated dumpsites on the territory". After that, it was a three way tie between Deforestation, the Amount of land owned by Individuals, and commercial ventures in residential areas.


Most of the participants felt the biggest obstacle to achieving a land use plan is community agreement. The survey also had a few questions about Land Use up in Tioweró:ton. People felt general preservation of the area, the cabin site areas and the hunting areas all need to be included in a Tioweró:ton land use plan

The most important land related issues in Tioweró:ton were disrespect to the land, lack of respect in general and disturbing the ecosystems.

The survey had some demographic questions and 3 out of 4 survey participants were women.

The survey results will be on the MCK Lands Unit webpage if anyone wants to give them a more in-depth look.

In October we finished another survey for land use in Tioweró:ton, survey participants for that one were from Kahnawà:ke and Kanesatake. we'll be releasing those results to the public in the near future.




