



Privacy and Respect Agreement for Chiefs

With reference to clause 4 of the MCK Declaration of Office,

I, _____, Ratsenhaienhs/Ietsenhaienhs in consideration of being an elected Chief remunerated by the Mohawk Council of Kahnawà:ke, ("MCK"), and other good and valuable consideration, the receipt and sufficiency of which is acknowledged, agree that, except as may be strictly necessary for the performance of my day to day duties as an elected Chief of MCK, any and all confidential information I obtain or am privy to during the course of my term of office with MCK will not be discussed with, disclosed or revealed to any other person or entity, unless authorized by the Mohawk Council of Kahnawà:ke.

I further agree that any and all documents or materials, including but not limited to letters, memoranda, legal briefs, file materials, photographs, drawings, video and audio tapes and computer discs, that may be provided to me by the MCK or that I may create, use, or obtain or am privy to during the course of my term of office with MCK, are and will remain the sole and exclusive property of the MCK and, except as may be strictly necessary for the performance of my day to day duties as an elected Chief of MCK or with the express written permission of an authorized representative of the MCK, will not be altered, destroyed, copied or removed from the MCK Building Complex.

I further agree that this Privacy and Respect Agreement is effective for the entirety of the term of office with MCK and will remain in effect and will be binding upon me following the end of tenure as an elected Chief with MCK.

I further agree that this Privacy and Respect Agreement is a fundamental term of my tenure with MCK and that, in addition to any other civil or criminal liabilities, a breach of this Privacy and Respect Agreement will be good and sufficient grounds for Disciplinary -Measures in accordance with the *Mohawk Council of Kahnawà:ke Disciplinary Measures Regulations* K.R.L. c., E-1 r.1 by Chief and Council.

I further understand that refusal to sign the present Privacy and Respect Agreement may result in my being excluded from meetings in which confidential information may be discussed or disclosed. Without limiting the generality of the forgoing "confidential information" means information that deals with:

- i) personal information related to an individual;
- ii) legal advice, opinions, strategy, or settlement discussions;
- iii) political strategy concerning relations with external governments;
- iv) business agreements that include a non-disclosure clause;
- v) any other matter that Council deems to be confidential.

I have requested that the present Agreement be drafted in English.
